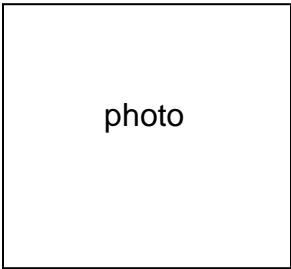

I declare that, to the best of my knowledge, all particular supplied by me are true and complete. I am aware that any false declaration will lead to my application being rejected or to the annulment of the visa already granted; furthermore it may also render me liable to prosecution under the law of the Schengen State which deals with the application. If granted, I undertake to leave the territory of the Schengen States upon the expiry of the visa. I have been informed that possession of a visa is only one of the pre-requisites for entry in the European territory of the Schengen States. The mere fact that a visa has been granted to me does not mean I will be entitled to compensation if I fail to comply with the relevant provisions of Article 5.1 of the Convention implementing Schengen and I am thus refused entry.
