



VISA CHECKLIST

SCHENGEN VISAS (SHORT STAYS, UP TO 90 DAYS)

All applications must be submitted including both BASIC and ADDITIONAL supporting documentation

BASIC DOCUMENTS (mandatory for all Schengen visas)		CHECK
1	Visa application form, duly filled and printed (Schengen Visa)	<input type="checkbox"/>
2	1 recent passport-size photos	<input type="checkbox"/>
3	Passport or travel document valid for at least 3 months after visa expiry date + photocopy. Passports must have at least 2 spare pages for the Visa	<input type="checkbox"/>
4	Driving licence or alternative document (Proof of Residency) showing current residential address in NSW	<input type="checkbox"/>
5	Australian visa (+ photocopy) or Copy of VEVO Confirmation – Visa to be valid for at least 3 months from date of exit from Schengen area	<input type="checkbox"/>
6	Copy of previous Schengen visas, if any available	<input type="checkbox"/>
7	Return-trip booking from/to Sydney plus all internal travel within the Schengen territory (train bookings, car rentals, etc.)	<input type="checkbox"/>
8	Proof of economic means of support: updated bank statement in the applicant/company name as shown on passport (transactions list of the last 3 months including current month).	<input type="checkbox"/>
9	Proof of available accommodation for entire stay in the Schengen area: tourist vouchers, hotel bookings, offers of hospitality (host declaration form) (dated, signed and with copy of photo ID), etc. Any proof of lodging needs to be under the applicant's name (as shown on passport)	<input type="checkbox"/>
10	Travel insurance: minimum coverage of €30,000 for medical reasons, emergency hospital, repatriation expenses including for body remains, valid for all Schengen countries and for the whole duration of the stay in the Schengen area policy (ONLY from European and local Australian insurance companies). EITHER Certificate of Insurance with Table of Benefits OR (for insurance through a credit card provider): Certificate of Insurance from the bank + confirmation letter from the bank + copy of credit card	<input type="checkbox"/>
ADDITIONAL DOCUMENTS (tourism)		CHECK
1	Letter of Employment or 3 recent pay slips	<input type="checkbox"/>

ADDITIONAL DOCUMENTS (business)		CHECK
1	Inviting Letter from the company in Italy (Form) with copy of their Business License/Chamber of Commerce certificate, confirming the purpose and duration of the visit and whether the host is covering any expenses for the trip	<input type="checkbox"/>
2	Original letter from the employer stating designation, date of employment, salary, period of stay, purpose of visit, stating full responsibility for employee's expenses during the trip and his/her return stamped OR documentation issued by the relevant local authorities proving the actual position of economic-commercial operator (e.g. : operating licence, company registration certificate , etc.)	<input type="checkbox"/>

1	Enrolment or pre-enrolment in the course to be followed in Italy	<input type="checkbox"/>
2	For regular University courses or University exchange you must consider a minimum of 417.30 EUR per month of stay. For all other courses (ex. language courses) a minimum of 864.59 EUR per month of stay	<input type="checkbox"/>
